EA COPY TRADE

EA COPY TRADE INSTALLATION TERMS AND CONDITIONS

- ***Have a Metatrader4 account***
- ***The account registered must be a new account (Account type: Standard variable)***
- ***Minimum account balance is \$1000***
- ***Fill out the EA registration form***
- ***Agree to the terms and conditions of EA management***

For the time being, Guardian Midas only serves EA Copy Trade installations for accounts from Exness service providers

EA COPY TRADE WORKING MECHANISM

- ***EA will execute transactions if there is an opportunity in market***
- ***EA will be active no later than 2 hours after making payment and receiving a successful activation email***
- ***The profit potential is unlimited***
- ***The maximum drawdown is -15% of the initial capital when using low risk. Clients have the right to choose their preferred risk level (low risk/medium risk/high risk).***

PROFIT SHARING TERMS

- ***The profit-sharing distribution is 80:20 each month (80% for the client, 20% for the management). If the profit is below 5%, the client is not required to share the profit. The client must transfer the profit-sharing amount to the specified account provided***
- ***by the management no later than the 7th of each month***

WITHDRAWAL TERMS

- ***Clients are advised to withdraw profits from their respective accounts on the 1st-5th of the calendar every month***
- ***If the client does not make WD profits on the date specified above, please contact EA management directly to avoid EA copy trade off status on your account.***
- ***If the client makes WD profit or WD capital outside the date above, the EA copy trade will automatically be deactivated***

Guardian Midas management is not responsible for the WD process in each client account

WHAT CLIENTS NEED TO NOTE

- ***It is not permitted to intervene in accounts that have EA installed in any form.***

(Example: client logs in on another device, then performs a manual transaction or close existing transactions)

The consequence is that the EA will stop operating & will have to re-register

It is recommended to log in using the investor password, not the master password (which is in give it to management)

- ***It is not permitted to top up with the knowledge or without the knowledge of EA management***

The consequence is that the EA will be deactivated or re-registered

If the client wants to top up, it is recommended to open a new account and do it re-registration

Note: if the client violates the terms and conditions mentioned above, the consequence is that the copy trade EA will be deactivated on the client's account.

GUARDIAN MIDAS GUARANTEE

The management will compensate for losses up to 7.5% of the capital.

Clients can submit a warranty claim under the following conditions:

If the initial capital decreases by 15% (low risk)

If the initial capital decreases by 30% (medium risk)

If the initial capital decreases by 45% (high risk)

The warranty is valid for 6 months from the activation date.
